Debit Card holder Agreement
(Please Read these Terms and Conditions carefully)

1. The Laws of Bangladesh shall govern all the Terms and Conditions mentioned in this form.
2. AIBL will accept Application for issuance of Debit card service on prescribed form duly filled in and signed by authorized signatories of the account only (subject to signature verification).
3. The Debit Card is, and will at all times, be the property of the Bank and shall be returned to the Bank unconditionally and immediately upon the Bank's request. The Bank reserves the right to cancel / withdraw at any time without prior notice or to renew at its discretion, the ATM and / or any service thereby offered at any time.
4. The Bank reserves the right to vary, modify and add to these terms and conditions and levy charges at any time, without notice and without assigning any reason whatsoever.
5. The Bank does not warrant and shall not be responsible for the services not being un-interrupted for any reason whatsoever.
6. The Bank shall debit the designated account for the amount withdrawn from any Automated Teller Machine (ATM) / Point Of Sale (POS) or any other payment gateway in Bangladesh by the use of the card. The Bank records generated electronically or other means shall be deemed to be conclusive proof of the correctness of the transaction(s) notwithstanding the fact that there exists no debit voucher signed by the card holder to support transactions.
7. The Card holder will have to maintain sufficient funds in his / her account, in order to facilitate continuity of service. This account will be debited with the amount of any withdrawal and / or other transaction effected by the use of ATM Card as well as the related charges there to the Bank's tariff.
8. Inconsideration of issuing the card, the card holder undertakes to indemnify the Bank against all losses, claims, actions, proceedings, demands, damages, costs and expenses incurred or sustained by the Bank whatever nature and howsoever arising out of or in connection with the issuance or use of the card, provided that the Bank acts in good faith.
9. The card and PIN are issued to the cardholder entirely at the card holder's own risk and the Bank shall bear no liability whatsoever for any financial loss, or any other loss, or damage whatsoever caused from this issue whether directly or indirectly and as a result of any transaction made with the card and shall be indemnified by the card holder, against any such loss or damage.
10. The card holder shall not disclose the PIN and will be liable to the Bank for any and all transactions made by the use of the card and hereby, agrees to indemnify the Bank for any loss or damaged howsoever caused by any unauthorized use of the Card or PIN, unless the Bank has received notice in writing of any loss, damage or theft of the Card or disclosure of the PIN prior to such unauthorized use of the Card or PIN.
11. The Bank reserves the right to disclose, in strict confidence, to other institution, such information concerning the Card holder's account as may be necessary or appropriate in connection with its participation in any Electronic Fund Transfer Network.
