PERSONAL UNDERTAKING FOR LA-RIBA HAJJ CARD UNDER TRAVEL QUOTA

In consideration of your agreeing to issue me LA-RIBA ISLAMIC Credit Card for hajj, I son/daughter/wife of Professional address do hereby affirm and undertake as follows:

1. That the LA-RIBA ISLAMIC Credit Card for hajj issued in my name and favor shall be utilized strictly in accordance with relevant exchange control regulations in force from time to time and shall be responsible for its misuse (if any).
2. That I shall be liable to pay any sum billed to my Card Account against the Card issued in my favor without your need to prove or to show grounds or reasons for your demand for the sum specified therein.
3. That I shall be liable to pay charges (Per Transaction ATM Fee) commission etc. thereon without any questions whatsoever upon your first written demand and my credit limit will be fixed according to balance of my account and also the Law of Guideline for Foreign Exchange Transaction.
4. That this undertaking shall be binding on me as well as on my heirs, successors and assigns.
5. a) that in the event of failure to comply with any of the rules and regulations relating to the issuance of the said Card or in liquidation the outstanding against the said card, I shall be liable for action under foreign currency rules and regulation imposed by Bangladesh Bank be debarred from La-Riba MasterCard Facility either at your instance or by Bangladesh Bank.
b) the under signed is also very much aware Hajj allocation/travel quota entitlement of Bangladesh nationals is set at USD 7000/- per year for visits to countries other than SAARC member countries and Myanmar. Quota for SAARC member countries and Myanmar is USD 5000/-.
c) I hereby irrevocable undertake that I shall never avail more than my Hajj allocation/travel quota entitlement during Hajj session / one calendar year as per exchange control regulation of the country and I also undertake to keep Al-Arafah Islami Bank Limited indemnified and harmless from any violation/deviation of the existing rules of the country.
6. I hereby undertake that I will keep Al-Arafah Islami Bank Limited indemnified from any transaction occurred during the period from stolen/lost to reporting time to card division.
7. That I do not/will not hold or use any International Pre-Paid/Credit Card of any Bank or Organization in Bangladesh.
