SEALED Tenders containing Technical Offer & Financial Offer are invited in Two separate Envelops from reputed and bona-fide Tenderers for 'Supply, Installation, Testing & Commissioning of 1000KVA Sub-Station Equipment including Busbar Trunking System works of 9 Storied building with 1 basement floor of 'Al-Arafah Islami Bank Hospital' at CDA Avenue, Mirzapur, Chattogram.

1. For issuance of Tender Document, the interested Tenderers shall have to apply to the undersigned in their letter head pad along with documentary evidences to meet the following primary eligibility criteria:
 - a) Tenderer must be competent in terms of legal, financial and technical capacity;
 - b) The Tenderer must have a minimum general experience in the field of Supply, Installation, Testing & Commissioning of 1000KVA Sub-Station Equipment including Busbar Trunking System works for a minimum of 10 (ten) years & specific experience in Commercial/Hospital building works of 5(five) years;
 - c) The Tenderer must have specific experience of successful completion of minimum 03 (three) number of buildings for Supply, Installation, Testing & Commissioning of 1000KVA Sub-Station Equipment including Busbar Trunking System works each not less than Tk. 2.00 (two) crore under Government or Semi-Govt. organization, Private Banks, autonomous bodies and reputed organizations during last 5 (five) years;
 - d) The Tenderer is financially capable to execute work of minimum Tk.3.00 crore and enjoying credit limit of minimum Tk. 1.00 crore;
 - e) The Tenderer possesses up-to-date valid Trade License;
 - f) The Tenderer possesses valid VAT registration certificate;
 - g) The Tenderer possesses up-to-date valid Income Tax return certificate.
2. Tenderers without primary eligibility as stated under Para 1 (a to g) above, need not apply for the Tender Documents.
3. Tender Document will be issued from the office of Al-Arafah Tower, Level-1, 63, Purana Paltan, Dhaka-1000 and consultant office "Fialka" at Press Club building (2nd floor), Jamal Khan Road, Chattogram (Phone: 618599) on cash payment of Tk. 6,000.00 (Taka Six thousand) only (non-refundable) per set from **08.04.2024** to **04.05.2024** during office hours.
